Please notify kennel personnel if you believe your pet could possibly have fleas or ticks. By doing so your pet can be treated immediately. Owner is responsible for this nominal charge if fleas or ticks are found on pet at any time while boarding.

The owner of said animal agrees that his pet is boarded or otherwise handled, cared for by us without liability for loss or damage from disease, injury, death, running away, theft, fire, injury to other animals, persons, to itself, or property caused by said animal.

The animal will not be taken off the premises without the owner's consent, except for veterinary care.

If your pet should become ill, we reserve the right, at our discretion, to call a veterinarian, administer prescribed aid, or place the animal in the care of a veterinarian. Any expenses so incurred will be the total responsibility of the owner. The owner will be notified as soon as possible.

Any charges for boarding, grooming, special diets, medications and veterinary care not paid for 30 days after they are due, or if your pet is not called for 30 days after the stated time for return, the animal will be sold by us for the best price available. Notice in writing of intended sale will be mailed by registered mail to the owner at the address hereon not less than 10 days preceding the sale. No further notice is deemed necessary. Any excess monies beyond that due to us will be rendered the owner. Any deficiency to be paid by the owner to the kennel. If an account is given to an attorney for collection, Owner agrees to pay all costs incurred, including reasonable attorneys' fees.

The owner or authorized agent represents he is the legal owner of the animal, that there is no mortgage or lien against the animal and that the animal has not been exposed to disease within the past 30 days.
